### COURSE DESCRIPTION

For each unit, students take a diagnostic test that assesses their current knowledge of fundamental content. The results of these tests help students create individualized study plans. This course engages students in selections from British and world literature from the ancient world through modern times. They practice analytical writing and have opportunities for creative expression*
