COURSE DESCRIPTION

High School English II-SE focuses on providing students with a deeper understanding of the most important Language Arts concepts needed to succeed in life. It is particularly effective for special education students. Course topics include: Elements of Short Story, Writing, Science Fiction and Mystery, Writing Biography, Autobiography, and Memoirs, Grammar and Vocabulary, Writing Personal, Expository, and Persuasive Essays, Writing Persuasive Speeches, Form, Language, Imagery, and Sound Devices in Poetry, Drama - Comedy and Tragedy.
