Unit 2: World War I & Treaty of Versailles	SS12.1.6 SS12.4.2 SS12.4.1	<p>Students will interpret the causes and effects of World War I.</p> <ul style="list-style-type: none"> Analyze the causes of World War I to explain how the war started (i.e., militarization, alliances, imperialism, nationalism, and the assassination of Archduke Franz Ferdinand). Identify new technologies and military tactics used in World War I that contributed to the casualty rates. Analyze the Treaty of Versailles and predict the implications on future events (i.e., Middle East Mandates, European countries, Communist Revolution).
Unit 3: World War II	SS12.4.4 SS12.5.2 SS12.4.2 SS12.4.5 SS12.6.2	<p>Students will determine the causes of World War II and its subsequent effects on the world.</p> <ul style="list-style-type: none"> Students will analyze the military strategies used in World War II. Evaluate the causes of World War II (i.e., Global Depression, Treaty of Versailles, League of Nations, appeasement). Analyze the rise of prominent dictators (e.g., <i>Hitler, Mussolini, Franco, Stalin, Tojo</i>). Compare and contrast the fighting on the European front with the military campaigns in the Pacific during World War II (e.g., <i>island hopping, sieges of cities, campaigns in North Africa</i>). Analyze the Holocaust and its impact on the world.
